Grants

The Commissioners discussed the Aquifer Protection grant, noting that it was based on a proposal from Rubicon related to the center gate and a measurement installation at Fish Creek. The entire project has been reconsidered and will be accomplished at a much lower cost and less disruption to the property owner. The Commissioners will contact the Aquifer Protection Board to see if the changes will still qualify under the grant, considering the goal of the project, better inflow and outflow data, is accomplished.

All Terrain is on track to do the creek clearing project this fall.

Maintenance

Steve Neff reported that he has been working with Bigfoot as they are installing the new sensors at the dam that allow the commissioners to remotely control the dam.

Laurin Scarcello will contact the property owner who reported a tree in the creek, to access whether or not a contractor will be needed to address the issue.
