The lake level is at 10.2. The side gate opening was 3/4" releasing 4 cfs. The SWE on Ragged Ridge was 6.1.

The Commissioners were provided with a list of payables due in March and a folder documenting the various amounts. **Adam Kremin moved to authorize the March payables as presented of \$2,225.71 as presented.
